

Talend Data Quality Service Supplemental Terms and Conditions

These supplemental terms and conditions for the Talend Data Quality Service apply to and are incorporated into the Agreement. All capitalized terms not defined herein will have the meanings given in the Agreement. The Talend Data Quality Service consists of the following:

1. **Definitions.** As used herein, the following capitalized terms shall have the meaning set forth below.
 - (a) "Data Quality Actions" means any modification (i.e. deduplication, standardization, data cleansing, etc.) of the data included within a Dataset in its originating source systems.
 - (b) "Data Quality Service Framework" means Talend Cloud Data Preparation and Talend Cloud Data Stewardship configured such that an End User and/or Authorized User, as applicable, may ingest or integrate, profile, standardize, track, monitor, and alert data quality status and actions.
 - (c) "Data Quality Service Subscription" means the Customer's right to access and use the Talend Data Quality Service on a subscription basis, as specified in the applicable Order Form, for the applicable number of Datasets.
 - (d) "Dataset" means a read only single table, file, query or object with no more than 1 million rows or 30 columns or one level of parent-child relationships between the data. Customer's base subscription includes five (5) Datasets; however, Customer may purchase additional Datasets. A Dataset shall be considered a part of Customer Data.
 - (e) "Dataset Under Management" means a Dataset loaded and managed within the Data Quality Service Framework.
2. **Talend Data Quality Service.** The Talend Data Quality Service includes: (a) Talend's assessment of Customer's Datasets Under Management by applying pre-defined rules for profiling, standardization, and sharing of data contained in the Dataset, (b) two (2) Named Users of Talend Cloud Data Preparation and Talend Cloud Data Stewardship for Customer's use with the Talend Data Quality Service (e.g., execution of Data Quality Actions) per every five (5) Datasets purchased, and (c) the applicable number of Datasets. Customer may provide up to the ordered number of Datasets to Talend to be loaded in the Data Quality Service Framework. Talend will notify Customer of Talend's acceptance or rejection of a Dataset within thirty (30) business days of delivery from Customer to Talend and will make commercially reasonable efforts to load each accepted Dataset into the Data Quality Service Framework within thirty (30) Business Days of such acceptance.
3. **Dataset Changes.** At any time, Customer may request that Dataset(s) Under Management be deactivated and Talend shall deactivate the requested Dataset(s) within ten (10) business days of receiving Customer's request. Up to ten (10) days prior to the anniversary of the applicable Order Form, Customer may request that Dataset(s) Under Management be replaced and Talend shall replace the requested Dataset(s) within thirty (30) business days of receiving Customer's request. Customer is responsible for identifying and submitting all Datasets and executing any Data Quality Actions.
